

PRESIDENT'S REPORT

MSOT had a productive year preparing and implementing the new 2010 member approved by-laws which became effective January 1, 2011. One of the major by-law changes was the restructuring of the organization including the change from an "Executive Committee" to a "Board of Directors". As a result of these changes, a new volunteer "Coordinator of Communications" position was created and the Board welcomed Julie Mitrevski to fill this position. Julie has already been working hard to ensure that a clear and effective update of MSOT activities is circulated to members, government, stakeholders and the public. We were excited to launch MSOT's "facebook" page on June 1, 2011; which provides both members and non-members frequent updates on MSOT initiatives. We hope to utilize social media to increase awareness of occupation therapy (OT) within Manitoba. As our organization continues to evolve and restructure throughout 2011 and beyond, MSOT will continue to develop a paid executive officer position to assist MSOT in reaching a broader base and increase the profile of OT in Manitoba.

Over the past year, the Winnipeg Regional Health Authority (WRHA) "OT Leadership Group", in conjunction with MSOT, is working to develop a comprehensive support and resource guide advocating for the profession of occupational therapy in primary care settings. In mid-January, this initiative was presented to the "Family Medicine Site Leadership" team meeting by the regional director of occupational therapy, Marlene Stern. The presentation was very well received, with many attendees requesting more information on the potential contributions of OT to primary care environments. Continued follow-up has been maintained, with an upcoming submission to the *Manitoba College of Family Physicians Newsletter*.

Other examples of MSOT's advocacy efforts include providing a response to Mental Health, Addictions and Spiritual Health Care's document *Achieving Mental Wellness through Resilience and Recovery*. MSOT identified "assistance with service navigation" and "improving transition points", particularly the transition from in-patients to out-patients, as issues impacting patient care. Please see our website www.MSOT.mb.ca for more details. In addition, a letter in response to the discussion paper for *Made in Manitoba Accessibility Legislation* was drafted by our Current Affairs Chair and submitted to the Disability Issues Office of the Provincial Government for January 31 2011 deadline. MSOT's response highlighted American and Ontario disability and accessibility legislation and how it might develop in Manitoba through encouraging OT involvement. The voice of MSOT was also heard when we submitted a letter to the Provincial Ministers of Health and Justice supporting a letter that was submitted by the College of Registered Psychiatric Nurses of Manitoba regarding security at Selkirk Mental Health Centre. MSOT advocated for fair and equitable treatment for all Manitobans with mental illness and emphasized the role of outdoor physical activity in recovery.

MSOT continues to represent members on various influential committees including the WRHA OT Leadership Group, University of Manitoba MOT Program Committee, School of Medical Rehabilitation Executive Committee, Winnipeg Technical College Rehabilitation Assistant Advisory Committee and the Professional Alliance of Canada (PAC).

The Professional Alliance of Canada (PAC) met via teleconference in January, and in person at the 2011 Canadian Association of Occupational Therapists (CAOT) Conference. As many of the

Provincial organizations struggle to maintain membership numbers, PAC members continue to share resources and ideas as both cost and time saving measures.

The MSOT Private Practice Group has completed a *Personal Health Information Act* (PHIA) privacy package and statement for the individual private practices to use. It is available for purchase through the MSOT office by MSOT members in independent practice.

MSOT will begin a review of the strategic plan and continue to look for opportunities to increase the awareness of OT in Manitoba, advocate with and for occupational therapists, and create professional development and networking opportunities for our members. As part of this initiative, we will be sponsoring a two day SAEBO workshop in October 2011. We remain open to sponsoring other professional development and networking events in Manitoba and welcome suggestions.

As always, the ability of MSOT to achieve these objectives relies on the financial support and active participation of all occupational therapists in Manitoba.

In the office, MSOT continues to rely on a close working relationship with the College of Occupational Therapists of Manitoba (COTM), sharing computer systems, office personnel, and office space.

PUBLIC RELATIONS COMMITTEE REPORT

2010 – 2011 has been an exciting time for both MSOT and the profession of occupational therapy! Since joining the MSOT Board of Directors in November 2010 as Public Relations Chair, I have had the privilege of working with many talented occupational therapists, student occupational therapists, and members of the community.

Occupational Therapy and Primary Care

In November 2010, I began working closely with Marlene Stern, Leanne Leclair, and Isabelle Boisvert to develop a comprehensive support and resource guide advocating for the profession of occupational therapy in primary care settings. Our goal was to communicate the variety of occupational therapy services that could further support comprehensive and accessible care to all Manitobans. A succinct, two-page hand out was developed for family physicians, which was complemented by a comprehensive resource list.

In mid-January, this initiative was presented to the Family Medicine Site Leadership Team meeting by the Regional Director of Occupational Therapy for the Winnipeg Regional Health Authority, Marlene Stern. The presentation was very well received, with many attendees requesting more information on the potential contributions of occupational therapy in primary care environments. There was also a keen interest in facilitating improved awareness of, and access to, occupational therapy services. Continued follow-up has been maintained, stay tuned for more exciting work being done in this area!

School of Medical Rehabilitation Open House

MSOT annually participates in the School of Medical Rehabilitation Open House. This year, myself as well as Michelyn Hasselfield, *Update* Editor, attended the event on behalf of MSOT. The Open House proved to be a wonderful opportunity to meet prospective students, and to promote the profession of occupational therapy. The MSOT standing banner, featuring the new MSOT branding, as well as information about the profession of occupational therapy, was prominently displayed at the MSOT booth. MSOT post-it notes were also provided to attendees.

MSOT meets “facebook”

In close collaboration with Julie Mitrevski, MSOT Communications Coordinator, a “facebook” page was developed for MSOT. This page is used to communicate current OT affairs, highlight the accomplishments of local occupational therapists, and share interesting resources with the community. As of August 1, 2011, the “facebook” page has over 75 fans!

Featuring the new MSOT logo, created in 2010 by Changemakers, 1000 business cards have been ordered! These will be a great promotional and networking tool in the coming years! COORDINATOR OF MEMBER SERVICES REPORT

At the end of the 2010—2011 fiscal year, there were 323 members registered with MSOT. This includes 314 active, six out of province and three life members. This number represents only 53% of individuals registered with COTM. It is important to note that while membership in many provincial occupational therapy associations across Canada is declining, the number of members registered with MSOT has remained consistent throughout the past few years. This reflects both the dedication and enthusiasm of our current membership and the need to increase the visibility and accessibility of MSOT to attract new members. It is important for occupational therapists to understand that they can join MSOT at any time in the year, and that their contribution is essential to not only the growth of MSOT, but the maintenance and survival of this Society. That being said, I encourage every MSOT member to recruit at least one occupational therapist to MSOT this year. Not only will this help MSOT volunteers deliver quality service, but it will assist occupational therapists across the province by improving visibility, offering professional development opportunities, providing representation, and advocating for policy change.

In the 2010—2011 fiscal year, I continued to attend monthly Board of Directors meetings, and ensured member's questions and concerns were addressed. I worked alongside the MSOT administrative staff to ensure current job postings, resources and educational opportunities were available to members in an efficient and timely manner. Finally, I spent time reviewing and drafting changes related to membership policy and by-laws.

As Coordinator of Member Services, I would like to thank you for your continued support and membership with MSOT. Your membership strengthens the occupational therapy community within Manitoba and provides a strong network of therapists to advocate for our profession and initiate growth and change.

CURRENT AFFAIRS/ PROFESSIONAL ADVOCACY REPORT

This year, I have had the privilege of being involved in new and exciting activities with MSOT. In addition to acting as the liaison to the OT and the Workplace subcommittee; highlights of the past year include the following.

- Review of the WRHA *Regional Recommendations for Falls Prevention and Management* document and forwarded a response to the Regional Falls Prevention Leadership Committee.
- Completion the *Manitoba Institute for Patient Safety Stakeholder Survey*.
- Submission of a response to the Provincial Government's *Discussion Paper for Made in Manitoba Accessibility Legislation*. This document was produced following the stakeholder consultation session that I attended in 2009 and will be used to help guide future accessibility legislation. Preliminary legislation was passed this year, and recommendations regarding accessibility legislation are to be expected in 2012.
- Review and response to the draft *Provincial Mental Health Strategic Plan*.

A new area that MSOT is beginning to Explore, is the role of OT in driving capacity assessment and reporting to driver licensing organizations. This project is still in the information gathering phase, and OTs in other provinces have been contacted for information about driving assessment and reporting in their jurisdictions. MSOT is hoping to increase the awareness of the importance of the role of OTs in driving assessment, and eventually advocate for changes in reporting methods.

CANADIAN ASSOCIATION OF OCCUPATIONAL THERAPISTS (CAOT) 2010/2011 ANNUAL REPORT

Over the past year, the CAOT Board met twice in person and once by teleconference. I attended the CAOT National Conference in Saskatoon in June. In November, the Board and staff participated in a lobby day on Parliament Hill, with a message to our MPs from CAOT. Our recommendations included:

- The development of a practical *Active Living Guide*, similar to the *Canada Food Guide*, that gives Canadians a clear idea of how to live an active life;
- support for maintaining the independence of older Canadians by promoting access to older driver retraining programs through initiatives such as government advertising and tax credits; and
- promotion for all Canadians to have the option to be as active as they can be by extending the Child Fitness Tax Credit to all, regardless of age.

As a result of my meeting with Joy Smith (MP Kildonan-St.Paul), I was asked to speak on behalf of CAOT regarding "Healthy Living for Canadians" to the Parliament Standing Committee on Health. I presented to the Committee in Ottawa on February 8th, alongside the Canadian Medical Association, the Canadian Nurses Association, Public Health Canada and Santé Publique du Quebec. The presentation was well received.

MSOT and CAOT presented the 2010 Citation Awards at a reception in December to Neil MacHutchon. He holds a number of titles including the Manager of Patient Care for Rehabilitation Ambulatory Services at the Health Sciences Centre in Winnipeg. Neil directly oversees multidisciplinary teams, including occupational therapists and is well respected for his management style and support of occupational therapy in direct service delivery and program development.

CAOT also hosted a 85th Anniversary Celebration on March 3rd in Manitoba. CAOT pins were presented to new members by Sue Baptiste, President, CAOT and Claudia von Zweck, Executive Director CAOT.

Highlights of the Board Meetings included revision to the CAOT by-laws to include a by-election process to manage vacancies that occur before the end of the pre-established term of office of CAOT Board Directors. Revision of individual membership criteria in the CAOT by-laws to offer alternatives to the requirement that all individual members must successfully complete the national certification examination. The revisions continue to reserve individual membership for occupational therapists that have met Canadian standards for the profession by requiring successful examination completion and/or full registration with a Canadian regulatory organization. This requirement is in addition to criteria for graduation from either an occupational therapy education program in Canada that has been granted Academic Accreditation or an occupational therapy educational program outside of Canada and recognized by WFOT plus Canadian citizenship or established primary residency in Canada.

The following position statements were approved:

- The revised position statement on Support Personnel in Occupational Therapy.
- Occupational therapy and cultural safety.
- Occupational therapy and aboriginal health.
- Client safety and occupational therapy.

Further, the Canadian Home Care Association position statement on Rehabilitation Therapy Services in Home Care was endorsed and the OTA/PTA accreditation policies and procedures were approved.

- the development of a strategic plan for university academic accreditation;
- the development of a strategic plan for the Canadian Journal of Occupational Therapy;
- advocacy activity related to promotion of coverage of occupational therapy services by third party insurers;
- professional issue forums at conference 2011 on the topics of pain management and occupational therapy and the role of occupational therapy and cancer survivorship; and
- hosting the 85th anniversary celebrations in locations across Canada.

I also continue to sit on the CAOT Risk Management Committee for the CAOT Board. To access previous highlights from board meetings, annual reports, the mid-year report, or membership statistics, please visit the "Members Only" section of the CAOT website under CAOT Affairs.

For the first year in many, CAOT/MSOT did not present any Citation Awards for 2011 due to a lack of nominations. Please consider putting in a nomination for a person or an organization who has demonstrated a commitment to the beliefs, values and work of occupational therapy.

This has been my third year on the Board of Directors and it has been a wonderful experience. I agreed to let my name stand for a second term and have been re-appointed for another three year term commencing October 1st.


