Privacy Kit \$300

The Manitoba Ombudsman oversees compliance with *The Personal Health Information Act* (<u>PHIA) which</u> requires that those in independent practice have written privacy policies regardless of the size of practice. To support the MSOT members in independent practice to meet this PHIA and COTM requirement, MSOT hired a consultant to develop ten policies and a number of forms. Private Practice Directory

\$75/year

MSOT publishes one COMPLETE Private Practice Directory (of all listings received at MSOT renewal) in January of each year to provide information to the public and others about private OT practices in Manitoba. To have a listing in the private practice directory you must be an MSOT member and owner/operator of an Occupational Therapy private practice. The fee includes one listing in the "Complete Listings" Directory, and the **exact same listing** in any/all of the other directories (Services for Children, Services for Adults, Return to Work/Ergonomic Services). Your directory listing can be amended at any time. The cost is \$75/year regardless of the time of year the listing is submitted, amount is not pro-rated.

Private Practice Business Network
